Deposits are \$200 and are Non-Refundable. You may choose your pup/dog in order as deposits were received as soon as they are posted for sale if your deposit has been received. In the event that your pup/dog dies while in my care, you may choose another pup/dog if available or receive a refund of your deposit amount back or stay on the list for upcoming litters. If payment in full has not been received by eight weeks of age, purchaser shall forfeit deposit and pup/dog will be placed back in available status unless prior arrangements have been made in writing and agreed upon by both parties. If at time of deposit the pup/dog is eight weeks of age or older balance will be due no later than two weeks from receipt of deposit unless prior arrangements have been made in writing and agreed upon by both parties. We cannot guarantee you a pup from a Certain litter/pair/dog at any certain time. We cannot guarantee momma dogs to conceive just because she was bred. Your deposit amount will continue to roll over to upcoming litters until you pick a pup. I cannot guarantee a time frame thar you'll get a pup. To the best of the breeder's knowledge, the above-mentioned pup/dog is free of any signs or symptoms of health defects as of the date said pup/dog leaves breeder's possession. Note that innocent or mild heart murmurs are not a serious health risk and are common in puppies and are not covered with the health guarantee. Also undescended testicles are not debilitating, or life threatening and are not covered with the health guarantee. Your pup/dog is a pet quality pup/dog and is not guaranteed to be fertile or suitable for breeding. We require spaying or neutering your pet. A licensed veterinarian has inspected the said pup/dog and it is found to be healthy and sound and showing no signs of infectious, contagious and/or communicable diseases. The Breeder will not be responsible for Parvo, Distemper or Corona virus after the pickup of the pup/dog. These are very contagious and can be contracted immediately after leaving the breeder, that's why we recommend you not to let them touch the ground or down NO WHERE until they have received all their vaccination. Purchaser agrees to have the pup/dog examined by a licensed veterinarian within 72 hours (about 3 days) from the time said pup/dog leaves breeder's possession. Failure to do so will void this one-year health guarantee. Purchaser agrees to send proof the pup/dog was examined within the 72 hours (about 3 days) failure to do so will void this one-year health guarantee. The breeder is not responsible for the pup/dog after it leaves their care. PLEASE PROTECT YOUR PUP FROM EXPOSURE TO ANY UNVACCINATED OR SICK DOGS UNTIL HIS/HER VACCINATION SERIES IS COMPLETE AND HIS/HER IMMUNE SYSTEM IS MATURE (DISCUSS THIS WITH YOUR VET). KEEP HIM/HER ON YOUR LAP OR IN HIS/HER CRATE WHEN GOING TO THE VET UNTIL VACCINTIONS ARE COMPLET BECAUSE THE FLOORS ARE COVERED WITH NASTY BACTERIA/ VIRUSES/ PARASITES THAT YOUR PUP WILL BE VERY HAPPY TO SNIFF AND LICK! NO acepromazine should be administered to the pup/dog at any time, please advise your vet that this drug is very dangerous to boxer. All puppies are guaranteed healthy when they leave us, a licensed veterinarian has inspected the said pup/dog and it is found to be healthy and sound and that it is not showing signs of infectious, contagious and/or communicable diseases. During the initial exam by your veterinarian, should he/she find the puppy to be at poor health risk or detect any life-threatening physical health problem that would require further vet care that was not discussed with you the buyer before or on pickup day, other than vaccinations, de-worming or treatment for any internal or external parasite or bacteria, you MUST contact the breeder within 24 hrs. No replacement will be given due to environmental conditions, immunity level, pneumonia, stenotic nares, mange, heat stroke, frostbite, conjunctivitis, fleas, ticks, ear infections, allergies, thyroid dysfunction, low blood sugar, ear mites, worms, hernias, kennel cough, Giardia, Coccidiosis, and other types of bacterial infection, or any other condition considered treatable (not life threatening) or common to the breed. THE BREEDER IS NOT RESPONSIBLE FOR VET EXPENSES OR MEDICATIONS AFTER THE SALE. In the event that a CONGENITAL defect (life threatening) is found which develops to the extent that the puppy must be euthanized before the AGE OF ONE, a replacement puppy will be offered to the purchaser chosen by the breeder with consideration to the purchasers' preferences, will be offered to the purchaser as soon as one becomes available of equal value. Purchaser must notify breeder within 48 hours (about 2 days) of euthanizing pup/dog and send documentation to breeder with supporting evidence from two unassociated licensed veterinarians that the pup/dog is being euthanized due to a congenital defect. No money shall be refunded ever. Should the PURCHASER decide on surgical options, the BREEDER will not be financially obligated. IF the PURCHASER decides to euthanize the puppy, or in the case of sudden death, an autopsy must be performed (at the purchaser's expense) by a licensed veterinarian to determine the cause of death. A copy of the autopsy report must be provided to the BREEDER to prove cause of death was indeed congenital. If such an UNLIKEY event occurs, the breeder will offer the purchaser a replacement puppy chosen by the breeder with consideration to the purchasers' preferences, as soon as one becomes available of equal value. If at any time the purchaser is unable to keep the pup/dog, he/she must let the Breeder be given first choice to take the pup/dog back. AT NO TIME SHOULD THE PUP/DOG BE PLACED IN A POUND, SHELTER, OR OTHERWISE DISPOSED OF. I will do everything I can to help you find your pup/dog a home if you decide not to keep him/her. The purchaser agrees to let the breeder/seller know if they are rehoming said pup/dog and the new owner would need to sign the contract also. The one-year health guarantee is for the original purchaser only. The purchaser agrees to keep the pup current on all vaccinations, de-worming, and heartworm preventative. The purchaser agrees that the pup is being sold as PET ONLY and won't be used for breeding purposes unless prior arrangements have been made. There will be an additional fee for breeding rights to be included and it will be at the breeder's discretion to allow breeding rights to purchaser. The purchaser agrees that once the pup/dog leaves the breeder's care, the breeder is no longer responsible for ANY injury, illness or disease that the pup may encounter. The purchaser agrees that there will be NO REFUNDS given back. Purchaser agrees to keep breeder updated on the condition of the pup/dog for the length of its life, sending an update at least twice a year. If pup/dog was sold with breeding rights the purchaser agrees pup/dog won't be used for breeding before 24 months (about 2 years) old or past 6 years old (females only). THE BREEDER/SELLER IS NOT RESPONSIBLE FOR VET EXPENSES AND/OR MEDICATIONS AND/OR ANY OTHER COSTS FOR THE PUP/DOG AFTER THE SALE. THE BREEDER/SELLER IS NOT RESPONSIBLE FOR THE PUP/DOG AFTER THE SALE AND AFTER THE PUP/DOG LEAVES BREEDERS/SELLERS CARE.

By my signature below, I agree to have this pup/dog spayed/neutered, (unless other arrangements have been made). We require you do this by no later than 12 months and no earlier than 6 months to ensure pup/dog is developed, if purchaser spayed/neutered pup/dog before 6 months old it will void the one-year health guarantee. If the requirements in this contract aren't met within the stated time or by the guidelines in this contract there is a fee of \$5,000 per breach event. I understand that this spay/neuter agreement is an agreement that this pup/dog will not produce a litter of puppies either as purposely bred or by accidental breeding.

The purchaser acknowledges that he/she has read and understands and accepts the terms and conditions of this whole contract fully, and that this contract is under the jurisdiction of the State of Kentucky, in the county of Martin. It is agreed that the place of venue shall be in Martin County Kentucky.

I, the purchaser of a Boxer from Mary Burke, hereby acknowledge that I have received a copy of this contract.
